International students must provide the following information:

PAYMENT PLANS

A. Tuition Guarantee Plan—Undergraduate Student Cash Plan. A student who enrolls in a program of study for which a tuition guarantee plan is available may elect to participate in the plan. The plan guarantees that the student will receive a refund of tuition and fees if the student is unable to complete the program of study within the prescribed time period.

B. Cash Discount Plans. A student who enrolls in a program of study for which a cash discount plan is available may elect to participate in the plan. The plan provides a discount on tuition and fees for students who pay their tuition and fees in full at the time of enrollment. The discount is 5% for students who pay their tuition and fees in full at the time of enrollment and 2% for students who pay their tuition and fees in full within 30 days of enrollment.

C. Installment Plan. A student who enrolls in a program of study for which an installment plan is available may elect to participate in the plan. The plan allows a student to pay their tuition and fees in installments over the course of the academic year. The student must make a down payment at the time of enrollment and then make regular payments throughout the year.
